The tabulation of votes reflects that:

- 1. The proposed budget in the amount of \$55,462,396 as adopted for the fiscal year 2019-20, was passed by a total of 479 in favor and 167 against.
- 2. Proposition No. 1 School Bus Purchase was passed by a total of 438 in favor and 147 against for three (3) 66 passenger buses; (1) 7-passenger school vehicle, for an aggregate total cost of \$425,000.00.
- 3. Shannon Edmondson and Matthew Jablonowski were elected as members of the Board of Education for full terms of five (5) years, commencing July 1, 2019, ending June 30, 2024.
