L. BOARD OPEN DISCUSSION Superintendent Roland mentioned a grant received by Becky Duell to be used for replenishing the garden at the K-8 building. Food Services also received two grants. The Board again discussed the main thoughts from the Thought Exchange. Improving communication will be a main goal of the Board, and the Culture & Climate Committee will endeavor to find ways to achieve this goal. Trustee Matyas explained the Board will reestablish a diversity task force. The entire Board charged the Culture & Climate Committee to begin work immediately to make this happen. President Edmondson explained the Board will hold a retreat this summer to update the mission, vision, and goals of the Board of Education.

M. VISITORS

Amber Stallman, 43 Penna Road, Johnson City, NY: Raised concerns regarding the superintendent search and the tight timeline. Discussed the Board's lack of transparency, lack of inclusion of parents/community, lack of thoroughness in searching for viable candidates in the larger pool.

<u>Lisa Sienkiewicz, 184 Virginia Ave., Johnson City, NY</u>: Requested more transparency regarding the characteristics the Board is prioritizing for the next superintendent.

Trustee Martinez explained the Board's role in searching for the next superintendent. The Board has a responsibility to parents, staff, and taxpayers to choose the person they feel is best suited for the position. The Board was duly elected by the residents of the district to take on this responsibility. President Edmondson echoed these thoughts. The Board will follow its legal obligations and will have a superintendent appointed by July 1, 2021.
